Reports from District Officers, Staff, and Affiliates

1 Treasurer's Report: Susan Liller presented the report. Friday and Saturday offerings for District Conference 2012 plus checks received after conference total approximately \$6000.00. Donations for Disaster Bucket received in the days preceding the retreat (via website and checks) totaled over \$3000.00.

New Business

- 1 Assignment of neutral committee for feasibility study of Outdoor Ministries and Woodland Altars (as decided at District Conference): Larry Tyner and Dave Shetler proposed there be a committee of 8 with 4 people focusing on programs and ministry and 4 focusing on facilities/property/land use.
 - 1.1 The committee is to be "neutral." Current staff and Outdoor Ministries members would not be included on this committee, although they may be consulted.
 - 1.2 The Ad Hoc committee who presented at District Conference (Curt Ankeny, Art Forman, Tammy McFadden, and Tony Price) have been approached about serving on this committee of 8. 3 of 4 have said they would be willing and the 4th is willing to consult and possibly serve.
 - 1.3 The committee reports to District Board. District Board will have to make a report on the work of the committee at the next District Conference. The committee will need to recommend a consultant to do the feasibility study with District Board approving the consultant.
 - 1.4 Concerns were raised about the cost of the study. We can chose to do the study without a marketing component to reduce costs.

- 1.5 People were also concerned how quickly the study can be generated. It was noted that we do not have to report final decisions at District Conference 2013, just the progress of the committee.
- 1.6 Burt Wolf made the motion to call a committee of 8 persons divided into 2 equal parts to fulfill the mandate that was passed at District Conference relative to the Woodland Altars property and Outdoor Ministries programing. Judy Boles proposed the amendment that this committee be formulated by the District Executive, the District Board Chair, and a member of the Outdoor Ministries Commission. They will be approved by the District Board. Steve Conklin seconded the motion as amended. The motion was affirmed.
