Old Business

Marketing Strategies for the District. How can the Southern Ohio District Board better connect and support our congregations and pastors? Ministry Review of the District Executive Update – Evaluations were sent out to the Board members via email and response is encouraged.

West Charleston's offer for mediation through KIPCOR – West Charleston is willing to pay for Phase I mediation cost of \$6,000. The remaining cost is \$7,500 per phase up to 3 phases. The Board discussed the potential cost beyond Phase I.

Motion: Accept West Charleston's offer for mediation in Phase I.

Action: The Board reached consensus to accept the offer for mediation.

In communicating with West Charleston, Pastor Ty is asked to let them know that the Board supports the process with concerns about the future funding and where that may come from.

#### **New Business**

Recommendations from District Lawyer, Gary Crim – Attorney Crim provided a recommendation for exploration of sale of Woodland Altars. There are three items that action is requested (another discussion came up about the need to address issues with the dam but it was not included in the list:

Authorize legal counsel to retain an appraiser. The Board is going to prayerfully consider the appraisal and revisit the need in the August meeting.

Authorize environmental consultant for buried gasoline tank. The CRC will address in their next meeting. Authorize bidding for correction of sewer-water line issue. The CRC will address in their next meeting.

Other – Program and Arrangements Committee for District Conference – based on the theme of working together, is adding a Saturday Disaster Relief School Kit event at Troy COB on August 23, 2014, 3:30 pm. The District will be requesting financial contributions for this event, not kit contents.
